Item 116 Movement Beyond Switching District of Connecting Carrier

IAIS owned or leased covered hoppers cannot be shipped to consignees on a connecting carrier outside stations listed in item(s) 300, 305, 310 and 315. **IAIS will assess a \$100 per car charge in addition to the freight rates in Items 300, 305, 310 and 315 on any IAIS owned, leased or controlled cars that ship beyond IAIS destinations.**

Exception 1: **Shipments without prior permission from IAIS Customer Service Manager, mjhanson@iaisrr.com, beyond IAIS destinations are subject to charges for Offline Movement of \$2,000 per car** charge for IAIS owned, leased or controlled equipment.

Exception 2: Cars terminating within the switching districts of IAIS Destinations shown in Items 300, 305, 310 and 315 are not subject to the \$100 offline fee.

Item 130 Car Orders

Car orders will be accepted by email. Order form can be found in Appendix A.

Effective October 1, 2022, all car orders are to be placed with IAIS Customer Service by the shipper of the grain.

Cancellation Penalty

IAIS will assess a cancellation penalty charge of one hundred and fifty (\$150.00) dollars per car against any car order cancelled or if cars are refused when offered. Penalty charges will be assessed to the party placing the car order. Requests for cancellation of car orders shall be sent via email or facsimile to the Director Customer Service
