- Rates can be used in reverse route
- Rates apply only for gondolas or hoppers
- No switching costs will be absorbed by IAIS except that as annotated above.
- All shipments are subject to the General Rules and Provisions of Tariff IAIS 6100 Series (Rules), IAIS Fuel Surcharge Tariff 9003 and IAIS Demurrage Tariff 6004 Series.
